1. Hooghly River Bridge Commissioners (HRBC) invites sealed tender in the prescribed Form from eligible and reliable Contractors as per particular below and will be received by the Senior Project Engineer-V, HRBC up to the time specified herein-

2 Name of work:- Construction of RCC Bridge near Moukhali Kheya Ghat over Matla River, connecting Matla-I G.P. of Canning-I block & Tambuldaha G.P. of Canning-II block in the district of South 24 Pgs.”- Rectification of defectively casted U/S girder A-1 span of Bridge no-1 due to bad workmanship of the agency during casting of the same (Phase-3)

3. Estimated value of work put to tender:- Rs 76,734.00

4. Earnest Money: Rs. 1550=00

Request for tender documents consisting of detail scope of work, project details, eligibility criteria etc. will **be purchased on 19.12.2025 up to 4.00 PM** from the Account Section of HRBC on payment of the cost of Tender document as shown in sl. no. 4.

Receipt of Tenders: All sealed tenders should be dropped in the drop box kept at the chamber of Sr. Project Engineer- V, HRBC not later than **2.00 PM on 26.12.2025** and the tender documents will be opened on the **same day at 03.00 PM** in presence of the bidders / representatives of the bidder who will present at that time.

9. Rate to be quoted by the bidders will be exclusive of GST and Labour welfare cess (if any).

10. The bidders are to quote their rate in % above/ below/ at PAR over the Priced Schedule attached with the tender including all taxes, duties etc except GST & Labour welfare cess (if applicable) which will be paid /reimbursed by HRBC as per Govt. rules from time to time.




